- Operator is responsible for the diposal of waste of paper and board in the appropriate containers. For failing to comply with the waste disposal procedure, there is a fine of € 250,00 per violation.
- The operator is obliged to act in accordance with the Dutch laws and regulations.
- The agreement is entered into as long as the municipality of Maastricht shall provide the licence to the Stichting Winterevents Maastricht for the organization of the event Magisch Maastricht Vrijthof. From the time that the municipality of Maastricht dissolves or ends the agreement, all rights and obligations agreed between the foundation and the operator expire.
- The operator ensures that there are no grounds for exclusion referred to in Articles 2.86 and 2.87 Procurement Act 2012 apply to him
- Alle mentioned prices are excluding 21% VAT.
- Mentioned rental rates and conditions do not apply to food sales intended for direct consumption. These require a separate application and other conditions apply
- The period of the event is subject to change and can be changed by order of the municipality of Maastricht.
